

## InterEST children's camp reservation and cancellation conditions

1. Registration for the children's camp organized by the NGO interEST is done through the registration form on the website [interest.edu.ee](http://interest.edu.ee).
2. The parent/guardian (hereinafter referred to as the "Registrar") undertakes to familiarize himself with the rules of the camp and introduce them to the child before the camp and submit a signed copy of the children's camp participant card bringing a child to the camp with true data. These documents are available on the Organizer's website [interest.edu.ee](http://interest.edu.ee).
3. After filling out and confirming the registration form, payment for the camp is made through online banking in the registration form from the current account in the name of the Registrant. In the event that the payment was made from the bank account of someone other than the Registrant, the Organizer must be notified by e-mail.
4. The reservation of the campsite is confirmed by the paid advance payment or the entire cost of the campsite.
  - 4.1. If an installment is paid during registration, the remaining cost of the camp must be paid no later than 2 weeks before the start of the camp.
  - 4.2. Registering for camp less than 14 days before the start of the camp, to confirm the camp site, the entire cost of the camp site must be paid immediately.
  - 4.3. If no later than 2 weeks before the start of the camp, the full cost of the camp place has not been received, the Organizer has the right to cancel the camp registration without refunding the advance payment.
5. By making the payment, the registrant confirms the truth of the information provided on the camp registration form and the right of custody/guardianship of the child registered at the camp.
6. The amount paid for the camp will be returned to **the extent of 100%**, when the cancellation notice reaches the organizer **2 weeks before** camp taking place.
7. When giving up a booking due to a child's illness (it is necessary to submit a parent/guardian's application and a medical certificate) later than 2 weeks before the start of the camp the Organizer has the right to with hold 60% of the cost of the campsite from being returned to the Registrant.

When the child leaves from the camp before the end of the camp shift due to a health condition, 40% of the cost of the unused camp days will be returned to the Registrant (it is necessary to submit a statement from the parent/guardian and a medical certificate).
8. The amount paid for the camp place will not be returned if the child is sent home from the camp due to a violation of the camp's rules or if the parent/guardian wants to take the child away from the camp place before the end of the camp change for any reason (except if the child gets sick).

9. The organizer has the right to withdraw from organizing the camp, notifying at the latest 10 days before the camp and by returning 100% of the amount paid to the Registrant for the camp within five working days to the account from which the payment was received by the Organizer.
10. If the camp is canceled due to national restrictions related to COVID-19, we will return 100% of the amount paid for the camp to the Registrant to the bank account from which the payment was received by the Organizer within five working days from the notification of the camp cancellation.
